As reported in the HERALD TRIBUNE, August 20, 2008 a group of neighbors in Turtle Rock worked together to install a butterfly garden around the small retention pond near the south end of Meadow Rush Loop.

This same article went on to say that Turtle Rock was designated as the newest Neighborhood Environmental Stewardship Team (NEST) Community. Their dreams to create a wild life habitat were successful! More than 200 plants of pickerelweed, duck potato, jointed spikebrush, bulrush, water lilies and golden can-

na were planted. Some of the volunteers who helped with this project in 2008 were Mike Watstein, Penny Thomson, Jane Slaughter, and Penny Rist.

The years however have taken a toll and today's garden is now a "diamond in the rough". Our Landscape and Grounds Committee has taken up the challenge of bringing this garden back to life. We hope to create a beautiful oasis in the middle of the community where residents can relax and enjoy a lovely natural garden setting full of butterflies, hummingbirds and other pollinators.

# **Report From The Treasurer**

- \* Our Common Grounds expense category had a number of significant expenses hit in April. The board approved several projects proposed by the Landscaping Committee. Street corner plantings were added to the south gate (\$612), along the east side of the north wall (\$1,152), around the paver areas between the pool house and clubhouse (\$1,446), and new plan trees were added in front of clubhouse #2 (\$600). Bloomings completed the installation of over 330 yards of pine bark mulch in all common areas (\$14,850). This is an annual expense. Our annual palm tree pruning was completed by Bloomings as well (\$7,304).
- \*\* Our Facilities Maintenance expense category also had some significant annual expenses hit in April. Our quarterly lake mitigation maintenance expenses from Aquagenix (\$16,667) is billed for monthly work throughout the quarter. We also had several wetlands invasive removal projects that recently were completed by Stantec. They included vegetation reduction in the middle and southern conservation areas (\$20,202), and a special vegetation reduction project in the stormwater ditch area to better facilitate drainage (\$13,100).



# **Manager's Message**



Memorial Day has come and gone, and July 4<sup>th</sup> is right around the corner. Summer is here, and the hot muggy days remind us of why we must cherish the days when it is cold out.

I want to thank everyone who came to the Board Meeting on May 7<sup>th</sup>. It was great having a full house. My only wish is that we could have that kind of crowd every month to participate in the day to day things going on in the community and not one hot-button topic.

I have been receiving a lot of visits and calls from concerned homeowners about the sides and rears of houses throughout the community. I have included the section from the Turtle Rock Homeowner's Manual that tells us the do's and don'ts about outdoor objects and furniture. Please self-police all rules so the Management Company does not have to.

Decorations, decorative objects, outdoor furniture, and pots, including but not limited to statuary, fountains, and birdbaths:

All the community's covenants and rules are designed to serve the best interests of the membership by assisting the Association in its efforts to protect the beauty, attractiveness, and value of the entire community. All decorations, including decorative flags, must be of a temporary nature, and with the exception of the year-end holiday season, should be displayed no earlier than 3 weeks before and removed no later than one week after the holiday or event, respectively. Decorations to celebrate the year-end holiday season should be displayed no earlier than the Thanksgiving weekend and removed no later than the second weekend following New Year's Day. All such decorations must not be of a type, or be placed or used in a manner, that is potentially damaging to property or considered to be hazardous, unsightly, or a nuisance. To this end, decorations should be in keeping with the holiday being celebrated and should not detract from the community esthetics or create discord. Any decorative lighting should be rated for outdoor use and shut off no later than midnight.

Decorative objects noted throughout this section are not permitted if visible from the common areas and streets with the exception of those items placed under the front loggia. Homeowners may place decorative accessory objects, such as pottery, statuary, planters with live or artificial plants, and outdoor furniture under the roof of the front loggia and/or the screened lanai area. Furniture such as upholstered sofas and chairs may not be placed under the logia. All decorative objects such as pots, planters, trellises, benches, garden figures, outdoor furniture and water features are allowed only with ARC approval.

Please note: Such items may pose a hazard during wind storms and should be moved indoors if not securely anchored. In addition to the ARC application, a site plan and photos of the proposed objects should be submitted.

# Architectural Review Committee (ARC)



Trees are one of the most important natural assets in Turtle Rock. With summer almost here and the pollen from the blooming trees largely behind us, we can take a deep breath and enjoy the varied trees that bring such great beauty to our community and home landscapes.

Trees provide a habitat for wildlife, help with erosion control, and produce carbon dioxide that helps purify our air and creates shade, which can provide more than a 10-degree temperature difference in covered areas.

The ARC would like residents to know of a change to the Turtle Rock Owners' Manual (TROM) that was recently distributed regarding trees. The TROM now states that no tree can be removed without ARC approval (p. 26). In the past, Washingtonian Palm removal was permitted without ARC approval. However, confusion over palm identification has led to some non-Washingtonian palms being removed in error.

As always, the ARC will receive and review your application, visit your property, and either approve or deny tree removal. In all cases, tree stumps must be ground below the surface. In addition, please refer to the TROM's section on tree removal and the appropriate and necessary replacement of the removed tree with either a hardwood tree or 3 palms depending on the number of existing trees on your property.

Even if you have the minimum number of trees in your landscape and are not required to replace a tree that must be removed, the ARC asks you to think about replacing it with a smaller tree – not only for the architectural curb appeal of your home, but also for the environment.

The Committee thanks you again for your cooperation and for making our Turtle Rock community more beautiful.

# **Landscape Committee Report**



The Landscaping and Grounds Committee met on April  $23^{\rm rd}$  and again on April  $24^{\rm th}$ . On the  $23^{\rm rd}$  the Committee met to specifically dis-

cuss the proposed improvements to the community center, community pool area and the north and south gate houses. Final painting quotes are being firmed up to paint the interiors of the community center and the gate houses, along with the pool area and re-staining of the pergolas. Also, final quotes are being obtained to have a deep cleaning done of these areas. In addition, replacing of the corroded faucets, urinal fixture, door handles and bathroom mirrors, along with replacing of the ceiling flood lights with LED retrofit bulbs in the pool area are being explored.

Of extreme importance is the condition of the gate houses. The sliding glass doors and screening on the doors is in dire condition. The North gate has one door that does not even lock. The Committee obtained quotes to replace the rollers, realign and clean guides, and change handles and locks on both gate houses, along with quotes to replace all screens on the screen doors. The Committee will be asking for approval of this expense at the June Board of Governors meeting.

On April 24<sup>th</sup> the Committee met with Shane Battle of Bloomings to review the ongoing landscape maintenance check list. It was noted that the Christmas palms have been planted in front of the community center and how beautiful they look. Shane also suggested that Hydretain, a wetting agent, be applied to the turf throughout the common areas in order to help keep the turf moist during the dry season. The Committee presented this recommendation to the Board of Governors in May and the application of Hydretain was approved.



"A love story for this generation... brings to life two people who couldn't have less in common—a heartbreaking romantic novel that asks, what do you do when making the person you love happy also means breaking your own heart?"

**The Help** by Kathryn Stockett (novel) 451pp. A young white woman in the early 1960's in Mississippi becomes interested in the plight of the black ladies' maids that every family has working for them. The book explores the curious dynamic between white women in the Deep South and the black women who raised their children.



**Gone Girl** by Gillian Flynn (mystery)419 pp. A perfect wife's disappearance plunges her husband into a nightmare as it rips open ugly secrets about his marriage and, just maybe, his culpability in her death. One of those rare thrillers, masterfully plotted, whose revelations actually intensify its suspense instead of dissipating it. The final pages are chilling.

The opening lunch in the summer series was held in May at the delightful buffet restaurant, Der Dutchman, which provides the best in Amish and Mennonite cuisine.


