## Actions from the December 6 Board Meeting

First of all, we wish all residents and their extended families a very HAPPY NEW YEAR!

Before we get into the December Board meeting recap, there are a few important announcements:

RATE INCREASES as of Jan 1—

- Our dues were increased to \$530/quarter. If you are on auto-pay, this will happen automatically. If you pay in any other way, be sure to pay the proper amount.
- Bar Codes have increased to \$50
- Community Center rental rates are now \$30/hour
- Lease Application fee is \$250.

We are pleased to welcome a new manager as of January 3: Nanette Thomas joins Sunstate Management after nearly a decade with another company. and leaves a community she has managed for as long. Their loss will surely be our gain! As has been the policy during the transition period between on-site managers, there will be no walkin availability to speak with Nanette. This will allow her the necessary time without interruption to become familiar with Turtle Rock and our requirements. The office is staffed from 8:30 to 12:30 M-F by our Administrative Assistant, Alvina, who will be glad to help you with most inquiries, or make an appointment if you do need to speak with Nanette.

- Deferred discussion regarding speed violation procedural revisions.

# **Natural Assets Committee**

## **Natural Assets Committee Fine-Tunes Its Inspection Process**

With 31 connected ponds; numerous inflow and outflow structures; acres of preserves, wetlands, and buffers; and extensive lowmaintenance zones (LMZs) bordering ponds, it is challenging to track and maintain Turtle Rock's critical natural assets. The Natural As-

sets Committee has recently formalized its process for inspecting and reviewing the status of natural assets with a monthly "tour" of key areas including but not limited to those about which residents have shared questions or concerns. Via site visits generally conducted the last Saturday morning of each month, members of the Natural Assets Committee travel through Turtle Rock to check on specific pond conditions; desirable and invasive plants; preserve, buffer, and wetland conditions including any incursion by vendors or residents; mechanical structures; and more. Since late September, the committee has also focused on damage caused by Hurricane Ian.

Thanks in part to these monthly on-site reviews, residents can rest assured that ponds and pre-

served lands not viewable from the road will get attention. Committee members, wearing badges for easy identification, may traverse swales or community property to access ponds and other natural assets for review. Committee members are mindful of resident privacy when near homes, but are also happy to talk with homeowners during the on-site reviews.



Sharon Preston-Folta grew up as the unknown daughter of Louis Armstrong. She

will share her story with us and talk about her documentary film, "Little Satchmo," playing at film festivals around the world this year. Preston-Folta was born in 1955. Her mother, Lucille "Sweets" Preston, was a performer from Harlem, New York, and was romantically involved with Armstrong for many years, but he was married to someone else — his fourth wife Lucille Armstrong. Preston-Folta said the world-famous musician and cultural icon felt like he couldn't publicly acknowledge a child born from an affair, but privately, she was part of Armstrong's life.



A surprise treasure just three miles from Turtle Rock is the 72 acre estate of the late (2012) Elling O. Eide. Mr. Eide, a world class collector of



books and art on Chinese and Asian history and culture, turned his estate into a beautiful, tranquil place for visiting scholars who shared his passion. Once only open to visiting scholars, The Elling Eide Center and Research Library is now open to the public. # **Architectural Review Committee**

### **NEW ARC PROCESS**

The Architectural Review Committee (ARC) is instituting a new, streamlined process for the New Year.

Traditionally, ARC decisions have been communicated to residents by "snail" mail letters sent from the Community Association Manager. That is a time-consuming and expensive process. The new process will simplify notifications by posting the results of ARC monthly meetings on the Turtle Rock website and discontinuing the use of letters. This will eliminate the need for 30+ letters, and postage, each month; a major benefit for residents will be the ability to find out committee decisions regarding ARC requests within one business day.

The committee performed a trial run of this process in December, after the Board approved the proposal, notifying individual residents who had submitted ARC requests of the availability of results on the Turtle Rock website. The trial run proved successful, so the new procedure will become effective January 2023.


After each monthly ARC meeting, residents may go to the website "myturtlerock.com" and select "Community Association" from the home page. Select "ARC Results" and a listing of monthly results will appear, with the most recent month at the top. Select the appropriate month and an alphabetical listing by last name will appear, detailing the ARC's decision for each request made that month.

ARC monthly meetings occur on Saturdays, and are scheduled as below for the next six months:

January 21 February 22 March 18 April 22 May 20 June 24

Our goal is to have results posted to the website on the following Monday. Please remember the deadline for submitting ARC requests is the 15<sup>th</sup> of each month.

If your ARC request is noted as APPROVED without fur-



If your ARC request is TABLED, an accompanying note will indicate why, usually because further information is needed. In this case, a member of the committee will contact you to resolve the issue. Once resolved, you will be notified by email that you may proceed, and a supplemental notation will be made on the following month's website results.

If your ARC request is DENIED, a note will indicate why it fails to meet the requirements of the Turtle Rock Owner's Manual (TROM). No further action will be taken by the committee, and you will need to submit a new request that conforms to the TROM.

### **Answers to TROM Trivia from previous page:**

- 1. False. The only approved exterior surface for homes is stucco, and ARC approval is necessary. (TROM III, B, 6). In lieu of building a stucco-covered low wall around your equipment, plant shrubs around the A/C pad to shield the view.
- 2. 12:00 noon prior to the day of pick-up, and back in by 10:00 pm on the day of pick-up. (TROM III, C, 6)
- 3. Sidewalks are the responsibility of the owner for maintenance such as cleaning. However, the Association took over structural repair maintenance, and letting management know about a lift or crack is helpful. Please note that if the structural damage is caused by landscape infringement (such as tree roots) or misuse, the required repair is your responsibility. The Association is currently seeking a company to conduct the structural repairs that have been identified to date. (TROM III, C, 13)

# From the WEST Corner of...

### Martin Luther King, Jr. Day

January brings such notable celebrations as National Swiss Cheese Day (Jan. 2), and National Bubble Bath Day (Jan. 8). It also brings a more serious and noteworthy day, that of Martin Luther King Jr (Jan. 16). Here's a brief bio of a man that rose above color, race, and religion. A man and day worth celebrating.

Martin Luther King Jr. (born Michael King Jr.; January 15, 1929 – April 4, 1968) was an American Baptist minister and activist, one of the most prominent leaders in the civil rights move-

ment from 1955 until his assassination in 1968. An African American church leader and a son of early civil rights activist and minister Martin Luther King Sr., King advanced civil rights for people of color in the United States through nonviolence and civil disobedience. He was Inspired by his Christian beliefs and the nonviolent activism of Mahatma Gandhi.

King participated in and led marches for the right to vote, desegregation, labor rights, and other civil rights. King was one of the leaders of the 1963 March on Washington, where he delivered his "I Have a Dream" speech on

the steps of the Lincoln Memorial. There were several dramatic standoffs with segregationist authorities, which sometimes turned violent. Several times King would be jailed. FBI Director J. Edgar Hoover considered King a radical and made him an object of suspicion. FBI agents in-


vestigated him for possible communist ties, spied on his personal life, and secretly

recorded him. The FBI in 1964 mailed King a threatening anonymous letter, which he interpreted as an attempt to make him commit suicide.

On October 14, 1964, King won the Nobel Peace Prize for combating racial inequality through nonviolent resistance. In 1965, he helped organize two of the three *Selma to Montgomery* marches. In 1968, King was planning a national occupation of Washington, D.C., to be called the

Poor People's Campaign, when he was assassinated on April 4 in Memphis, Tennessee. His death was followed by national mourning, as well as anger, leading to riots in many U.S. cities. posthumously was King awarded the Presidential Medal of Freedom in 1977 and the Congressional Gold Medal in 2003. Martin Luther King Jr. Day was established as a holiday in cities and states throughout the United States beginning in 1971; the holiday was enacted at the federal level by legislation signed by President Ronald Reagan in 1986. Hundreds of streets in the

U.S. have been renamed in his honor, and the most populous county in Washington State was rededicated for him. The Martin Luther King Jr. Memorial on the National Mall in Washington, D.C., was dedicated in 2011.

# **Landscape & Grounds**

The Committee met at the Community Center on December 14, 2022. Present were Curt Gilroy, Kathrin Harris, Emily Miller, David Alcala and Jodi Cunnison. Shane Battle from Bloomings could not attend the meeting, however he emailed the Committee an update regarding the work completed or planned by Bloomings:

- a quote for replacing the oak and irrigation on the island at the SW corner of Far Oak Circle; a breakdown has been requested;
- the hedge along Turtle Rock Blvd at Meadow Rush Loop north has been trimmed;
- plantings at the north end of the nature trail and filling of gaps of the Awabuki hedge along Central Sarasota Blvd will occur within the month; this includes repairing the irrigation system that services the hedge;
- Bloomings has removed tree branches in the pond behind the Community Center, the pile of fronds at the north gate, fronds behind homes at the intersection of Turtle Rock Blvd and Nice Way;
- Mulching common areas is also on the agenda, however, there is a material shortage and the committee is also considering changing the type of mulch used.

Robert Davie, a renowned Sarasota landscape architect, presented his proposal for the enhancement of the butterfly garden. This proposal includes a fresh garden design, along with repositioning of the boulders that are currently at the location. The Committee was pleased with his recommendations and will pursue this further with Bloomings, who will do the final installation in spring or summer.

Other issues addressed by the Committee included:

- The status of the sidewalk repairs. The scope of the repair work is to be verified before moving forward with this project.
- Several street signs and light poles need to be straightened out as a result of Hurricane Ian. A quote to have this done will be obtained.
- Whether a Little Lending Library should be installed in Turtle Rock.
- Whether bat houses should be installed in Turtle Rock. IF ANY RESIDENT OF TURTLE ROCK
   IS EXPERIENCING A BAT PROBLEM,
   PLEASE CONTACT A MEMBER OF THE LANDSCAPE COMMITTEE.



# Turtle Rock Library Feature Book of the Month



### The Pull of the Stars

By Emma Donoghue (historical fiction) 304 pp

In 1918 Dublin, Ireland, a city ravaged by war and disease, nurse midwife Julia Power works at an understaffed hospital in the city center, where expectant mothers who have come down with the terrible new Flu are quarantined together. She is aided by Dr. Kathleen Lyon, a rumored Sinn Fein activist on the run from the police (and actual historical figure), as well as a young, inexperienced volunteer, Bridie Sweeney. In the darkness and intensity of this tiny ward, over three days, these women change each other's lives in unexpected ways. They lose patients to this baffling pandemic, but they also shepherd new life into a fearful world. With tireless tenderness and humanity, carers and mothers alike somehow do their impossible work. This is the first "pandemic caregiver" novel of 2021, though writing began in 2018, inspired by the centenary of the Spanish Flu pandemic of 1918.
