President's Message

At the June 29 Board meeting, the Board approved funding requests to:

- (1) expand maintenance provided by Crosscreek to include additional preserve border areas;
- (2) remove a tree stump along the border wall on Sabal Lake Circle;
- (3) repair the pavers at the north entrance and in the picnic area near the community center; and
- (4) repair the air conditioning at the north gate.

The Board discussed the establishment of a permanent committee to develop and implement a plan for Emergency Communications. If anyone would like to be a member of that committee, please contact Alvina or Nanette in the Community Center. Also discussed was the current cost of the traffic cameras. The cameras have been in place since last year, and implementation has proved to be very difficult. Therefore, until a cost-effective implementation plan can be developed, the contract with Traffic Logix will be suspended.

Last month I discussed our operating budget and how that portion of

your quarterly dues are spent. The remainder

of your dues are allocated to our reserve accounts. The reserve accounts are monies set aside and accumulated to pay for repair or replacement of common areas as they age. We maintain seven major reserve accounts (roads & parking; roofs; painting; building composite improvements; FF&E—furniture, fixtures & equipment). The association has a reserve study performed annually to determine the remaining life of all of our common area assets and their anticipated replacement cost at that future time. Based upon that study, it is determined how much money needs to be allocated to each reserve account. The 2022 study indicated that Turtle Rock reserve liabilities amount to \$5,618,000, of which we have accumulated approximately \$2,050,000 in total (about 36%).

Part of the board's fiduciary responsibility is to make sure the services we acquire for the management and security of the community are being provided effectively and cost effi-

What's going on with irrigation??

Since June 26, the northern third of Turtle Rock (all streets north of Sweetmeadow), plus Palmer Ranch Parkway and the Stonebridge community to our north, have been without irrigation. There is a leak in a 10" main line running along the east side of the Boulevard, and the county has shut it down since the leak was allowing reclaimed water to discharge into the preserve, an EPA violation. The hope is that the repair will be addressed on July 7...hopefully not too late for many lawns and shrubs. Sadly, once our St. Augustine grass is dead, it will NOT come back.

Stonebridge has already had to rip out their annuals at the entrance, while our entrance area (fortunately) still has water due to being directly linked to the main line that runs east/west along Palmer Ranch Parkway. If you live north of Sweetmeadow Cir, there is not much you can do but pray for rain or hand-water vegetation you hope to salvage.



Gate Access Task Force

The Board of Governors (Board) approved the creation of The Gate Access Task Force on April 5, 2022, reinstating the group during its February 7, 2023 Organizational Meeting.

The current Task Force was chartered to review, revise, and expand upon the work of the prior task forces, including — without limitation — the relevant data, potential vendors, and operations information. The objective of the Task Force is to make any recommendations to the Board for alternatives to improve the current gate access, and propose possible implementation strategies to achieve such improvement

This year's Task Force members are as follows: Russ Gill (HOA President)- Board Liaison Ken Rosenmann- Chairman Larry Bauman, Patty Fleming, Len Friedlander, Dennis Miller, Bob Oram, and Steve Parella.

The Task Force has been meeting on a regular

basis since last year's creation and is currently looking at the following areas for potential recommendation to the board:



- 1. Sending out an RFP for Attendant Services for 2024 to test the market and the pricing.
- 2. Revising the Post Orders to clearly define Turtle Rock's expectations of the Attendants.
- 3. Conducting 24-hour traffic counts to get a clearer idea of the number of vehicles entering through the visitors' gates.
- 4. Designating the South Gate as the main entrance due to increasing neighborhood traffic along Palmer Ranch Pkwy and because of its longer entry way.

We will update the community as the Task Force considers any additional improvements. Meanwhile, please don't hesitate to contact us with your questions.

Turtle Rock IRRIGATION Policy

Updated and circulated to the community via email June 16

The Association recently published a policy to confirm that issues regarding lines leaking, irrigation bursting, or unable to be shut off are the responsibility of TR owners. All homes are equipped with shut-off valves located just inside the property line past the common-property easement. The location is marked on the concrete curb with an **R**, and all valves should be easily accessible in case of emergency.

However, over the years, vegetation or even large tree roots have in some cases made the valves inaccessible. If you do have a leak or a solenoid is stuck in the "on" position, you have a

serious problem when the valve cannot be found or reached for a quick shut-off. Water will spray uncontrolled until the valve is located. We URGE all owners to look for their valve, open the lid, and make a trial run at shutting the flow off. If you are unable to do this, please be proactive and contact an irrigation company to unearth your valve box.

The recent policy was written to clarify that the Association's responsibility for the irrigation lines end where your property starts. In the past, Turtle Rock has allowed our maintenance staff to provide a service of locating and turning off your irrigation system when a valve gets stuck or a leak is observed. With the aging of our neighborhood, this service was consuming an extensive amount of the maintenance staff's time. Therefore, Turtle Rock will no longer be able to provide this service. Over the last few months, Turtle Rock,

through Turtle Talk and emails, has provided information about maintaining your irrigation system and locating vour irrigation valve boxes. During this time, Turtle Rock has also investigated and obtained a list of companies that will assist you in an emergency in locating and properly maintaining your irrigation system.

immediately, Beginning any irrigation issues should be referred to your irrigation company. If you do not have one, or they are unable to respond in desired timeframe, then you can call the companies listed below that will come to your home and provide the

necessary EMERGENCY services. They will come out within 24 hrs for emergencies (can't turn water off, etc.). When you call, please inform the company you are a Turtle Rock resident with an emergency, and they will provide services within 24 hours. If other services are needed, you can contact the below companies for an appointment. These companies will directly bill you, the resident, for their services. The agreed upon billing amount is \$150 trip charge including the first hour at your home. You will also be charged for any parts or materials they need to fix your irrigation issue.
