We have transitioned to a new property management company, Civix. Nanette Thomas remains our property manager as an employee of Civix. We have a new assistant manager, Nan Patton, replacing Alvina Decker. Nan will be on-site in the Turtle Rock office Monday through Friday from Noon to 4. The Turtle Rock community office number to contact either Nanette or Nan remains 941-921-3865. As we complete all of the final data transfers from Sunstate to Civix over the next few weeks, you will be receiving communications from Turtle Rock and Civix. In late November or early December, you will receive an "invitation" from Civix via email to establish an account on the property management software, AppFolio. I encourage you to establish your account since in the future much of the paperwork and contacts will be done through AppFolio. Civix will conduct training sessions for owners and residents on the use of this software. This training will show you how to use and

access your property's records, including your payment history, ARC forms and any other documents associated with your unit. You will be able to pay your quarterly assessments on-line or update your personal information.

At the October 25 Board meeting the Board approved funding for: (1) repair of the community pool skimmer, (2) replacement of carriage lights at the north and south gates, (3) removal of the overgrowth in ponds 18 and 19 (Far Oaks Circle) and pond 27 (Treesdale Court) which is obstructing the free flow of water in our retention ponds, and (4) approval of the 2024 budget which increases the quarterly dues to \$615.

Two items were discussed: (1) pickup truck parking within Turtle Rock, and (2) the creation of a volunteer group to assist Nanette in performing compliance reviews. Concerning the pickup truck parking the Board discussed multiple possible directions the community could go moving forward. In the final out-

Board meetings will be held the LAST Thursday of each month starting at 6:30pm during 2023. outcome the only way forward is to rewrite the existing Declaration of Covenants which were created by the developer in 1994. The Board will be establishing a task force to begin the rewrite and will proceed with the assistance of our association attorney. This is a significant task to rewrite the Declaration of Covenants and an even larger task to obtain sufficient votes to make any modification. The current Declaration of Covenants requires a 2/3 majority of all Turtle Rock owners to vote yes (506 yes votes) to change any part of the document.

Concerning the volunteer group, a proposal was made by an owner that the Board create a volunteer group to assist Nanette to review Turtle Rock properties and refer any violations to Nanette. Nanette recommended against creating such a group and the Board agreed with her recommendation. The subject was dropped.

The Gate Access Task Force in their review of our gate entry processes, discovered our gate attendants receive more than 30 phone calls per day requesting a visitor be entered into the gate access system. This diverts them from performing visitor check-ins and causes backups at the gates. Three years ago, Turtle Rock implemented software to allow owners to enter their visitors online. That software is GateAccess. I ask that you use the GateAccess system to register your visitors. You can enter them into the system as permanent visitors or visitors for a fixed period of time. You can access the GateAccess system either from your computer at gateaccess.net or from your smart phone by downloading the mobile app GateAccess from your app store. To use the system, you will need to obtain a login and password from Nanette if you don't already have them.

# From The West Corner Of...

There's no need to cry over spilled milk, but what about chopped onions? You can thank a chemical combination of enzymes and sulfur for the tears that well up while you make dinner.


Onions use sulfur to make a mixture of amino acids and enzymes during the growing process. The acids and enzymes are separated and stored in differregions of the onion's cells, which are called vacuoles. While the onion remains whole, the amino acids and enzymes in the onion's cells remain separated. Once you cut into the onion, however, everything mixes together. When substances are combined, they the two form a chemical known as syn-Propanethial- S-oxide, or lachrymatory factor (LF). LF is an irritant that's easily vaporized when it reacts with the air.

LF isn't strong enough to affect tougher parts of your body such as your skin, but it can irritate more sensitive regions. As the vapors waft up toward your face, your eyes will begin to sting. Your body — sensing the irritant — will release a torrent of tears in an attempt to wash the chemicals from your eyes. Luckily, LF can't do any serious damage, even in high quantities.

Producing LF is the onion's way of <u>defending against</u> anything that may want to eat it. As soon as an animal bites into the root, its eyes start to burn and it's reminded to stay away from onions.

Unfortunately for onions, humans are persistent.

# **Nominating Committee**

## **Attention All Residents...**

The Turtle Rock Nominations Committee is seeking applicants to serve on the Board of Governors. Only self-nominations are accepted because serving on the Board is a responsibility that requires a personal commitment of three years, unless filling a vacancy, and a desire to fulfill that commitment. Board members do more than merely attend the monthly meetings. Each of Turtle Rock's task forces and committees has a Board member who serves as a liaison to the Board. The Board works closely with both the management and vendors to ensure that we remain a desirable community in which to live. Once elected the Board has its Organizational meeting and elects its officers, who take on added responsibility.

Turtle Rock home owners at least 21 years of age who meet the minimum requirements are eligible to self-nominate. You must:

- not be delinquent in payment of dues or other monetary obligation to the Association;
- not be in violation of TR rules, and
- not have been convicted of a felony (if so, have your civil rights restored for five years)

We are looking for those individuals who have taken the time to familiarize themselves with our governing documents

(Declaration and By-Laws) and with the Turtle Rock Owner's Manual (TROM), both of which can be found on the website <a href="www.myturtlerock.com">www.myturtlerock.com</a> under the heading Community Association Documents. You may also be a good candidate based on your professional background and experiences or on your participation on other Boards and committees

All owners will receive the nominations materials in the mail. Applications (also found on the last two pages of this newsletter) are due in the Turtle Rock Community Center no later than 1 pm on December 30. If there are more candidates than open positions, a Meet the Candidates Night (required attendance for applicants) will be held in person and via Zoom, with elections to follow. Once they begin their 3 year term, newly elected Board Members will also need to complete an approved course pertaining to FL statutes for HOAs which is free and available online.

Thank you for your consideration to apply as a Board candidate.

The Board of Governors appointed Nominations Committee is seeking candidates to serve on the Board to commence in February of 2024.

Eligible candidates include any Turtle Rock Home Owner Association Member of record who:

- Self nominates
- Is at least 21 years of age
- Is eligible to serve according to FL Statute 720.306 (9) and the Turtle Rock Bylaws (Please review these at www.myturtlerock.com under heading Community Association/Documents)
- Is not delinquent in the payment of any dues, fine or other monetary obligation to the Association
- Files a timely and completed application
- Has not been convicted of any offense which is considered a felony, unless such felon's civil rights have been restored for at least 5 years from the date applications are due to be submitted.

#### REQURIEMENTS AND EXPECTATIONS:

The following is a list of <u>requirements</u> for Board Service:

- Have prior service on a committee, Task Force, Board, or with a community organization
- Certify knowledge and understanding of the Turtle Rock Community Association's Declaration of Protective Covenants, Conditions and Restrictions, Articles of Incorporation, Bylaws and the latest version of the Turtle Rock Owners' Manual (TROM)
- Certify knowledge and understanding of FL Statutes pertaining to HOAs, especially 720
- Take, and satisfactorily complete. HOA Board Certification course through a division-approved education provider (offered throughout the year and free of charge)
- Acknowledge and agree to the Turtle Rock Code of Ethics
- Appear in person for the "Meet the Candidates Night" held in the Community Center 2 weeks prior to the election
- Serve a 3-year term
- Attend all Board meetings (with no more than 5 meetings to be attended via teleconference), unless prior arrangements have been made through the Board President
- Hold the position of Board Liaison for one (or more) committees or Task Forces, and by doing so, serve as the bridge between the working group and other members of the Board

#### The following is a list of *expectations* for Board Service:

- Spend the time needed to uphold the documents and policies to the best of one's abilities, agree to faithfully discharge one's fiduciary responsibility to the Association's members, and be fully prepared for all Board, committee or other pre/post meetings necessary in Board meeting preparation
- Actively listen and respond with respect to fellow board, committee, community members, management, and vendors
- Donate a minimum of four to six hours a month for meetings, planning, participating with committees, review of reports and other correspondence, etc.
