Justin Gonzalez, Civix Partner, attended our board meeting and provided a brief overview of himself and Civix. The Turtle Rock community office number to contact either Nanette Thomas or Nan Patton remains 941-921-3865.

We have completed all of the data transfers from Sunstate to Civix. You will soon be receiving communications from Turtle Rock and Civix with information on accessing the new software AppFolio. The "invitation" will come from Civix via email with instructions on how to establish an account on the property

management software, AppFolio. I encourage you to establish your account since much of the paperwork and contacts will be done through AppFolio.

Civix will conduct training sessions for owners and residents on the use of AppFolio in January.

This training will show you how to use and access your property's records, including your payment history, ARC forms and any other documents associated with your unit. You will be able to pay your quarterly assessments on-line or update your personal information or fill out an ARC form.

Attention All Residents...

The Turtle Rock Nominations Committee is seeking applicants to serve on the Board of Governors. Only self-nominations are accepted because serving on the Board is a responsibility that requires a personal commitment of three years, unless filling a vacancy, and a desire to fulfill that commitment. Board members do more than merely attend the monthly meetings. Each of Turtle Rock's task forces and committees has a Board member who serves as a liaison to the Board. The Board works closely with both the management and vendors to ensure that we remain a desirable community in which to live. Once elected the Board has its Organizational meeting and elects its officers, who take on added responsibility.

Turtle Rock home owners at least 21 years of age who meet the minimum requirements are eligible to self-nominate. You must:

- not be delinquent in payment of dues or other monetary obligation to the Association;
- not be in violation of TR rules, and
- not have been convicted of a felony (if so, have your civil rights restored for five years)

We are looking for those individuals who have taken the time to familiarize themselves with our governing documents (Declaration and By-Laws) and with the Turtle Rock Owner's Manual (TROM), both of which can be found on the website <u>www.myturtlerock.com</u> under the heading Community Association Documents. You may also be a good candidate based on your professional background and experiences or on your participation on other Boards and committees.

All owners will receive the nominations materials in the mail. Applications are due in the Turtle Rock Community Center no later than **1 pm on January 12**. If there are more candidates than open positions, a Meet the Candidates Night (required attendance for applicants) will be held in person and via Zoom, with elections to follow . Once they begin their 3 year term, newly elected Board Members will also need to complete an approved course pertaining to FL statutes for HOAs which is free and available online.

From The West Corner Of...

Food Marketing



Despite its Danish-sounding name, Häagen-Dazs was established in New York as a clever marketing strategy. The name itself doesn't have any specific meaning in Danish or any other language. Instead, it was crafted to convey a sense of sophistication and premium quality. The two little dots hovering over the first "a" in Häagen are known as an umlaut, traditionally employed to indicate a change in pronunciation. Interestingly, however, Danish, the language that inspired the name Häagen-Dazs, does not even incorporate umlauts in its language.

<u>The City of Brotherly Love</u> has clearcut claims on many food origins cheesesteaks, <u>stromboli</u>, and <u>even</u> <u>root beer</u>. But despite the name, Philadelphia Cream Cheese is definitely not from Philly. The iconic dairy brand secured its misleading name (and gold-standard status) thanks to a marketing ploy that's been working for more than 150 years ... and it's all because of Pennsylvania's reputation for <u>impeccable</u> <u>dairy</u>. Small Pennsylvania dairies of the 18th and early 19th centuries were known for using full-fat milk and cream to make rich cheeses in contrast to New York dairies, which mostly used skim milk and because the perishables couldn't be easily transported, they gained a reputation as <u>expensive</u> <u>luxury foods</u>.

So when upstate New York entrepreneur William Lawrence began making his skim milk and (for richness) lard-based cream cheese in the 1870s, he needed a name that would entice customers and convey quality despite it being made in Chester, New York, and not Philadelphia. Together with cheese broker and marketing mastermind Alvah Reynolds, Lawrence branded his cheese under the Philadelphia name in 1880, which boosted sales and promoted its popularity with home cooks well into the early 1900s.

Crosscreek has installed beneficial aquatic plants along the littoral zones where Geotube has been added.



Landscape & Grounds By Jodi Cunnison



The Committee met on November 8th at the Community Center. In attendance were cochairs Curt Gilroy and Joan Howe, Board liaison Kathrin Harris, and members Dave Alcala, Diane Geramanis, Emily Miller, Jodi Cunnison and new member Deirdre Cronin. Welcome Deirdre! Also in attendance were Nanette Thomas from Civix Property Management, and Shane Battle from Bloomings.

Shane provided an update for Bloomings. The beds along Turtle Rock Blvd have been mulched, following a debris cleanup by Bloomings. The irrigation system behind the north side of Nice Way was repaired in October, and the vines and weeds growing throughout the Areca Palm hedge were removed. Stepping stones and additional plantings were added to the Serenity Garden, and Bloomings will be replacing any plants that have died in the garden. Sod has been laid at the south entrance where the dead Arboricola hedge had been removed, and mulch has been added around the flagpole at the Community Center.

Since we are still experiencing a drought, the installation of carissa plants at both medians at the north and south gates, along with the replacement of the dead plants at various street corners along Turtle Rock Blvd will be delayed until the cooler weather moves in, which will hopefully bring us much needed rain. Discussion was had regarding the exact placement of two new Shady Lady trees by the south gate overlooking the pond, along with the placement of several additional trees along Turtle Rock Blvd as per the Board of Governors approved landscape refurbishment. The Committee will get back to Shane .regarding the exact placements of all trees. The bare spots in the hedge along Central Sarasota Parkway will be filled in with Pitch Apple trees in November. Shane was asked to come up with an estimate to improve the irrigation system at various street corners along the Blvd, along with an estimate to replace the dying hedge along Pond 6.

The Committee is continuing to investigate a solution to the shell sidewalk repair at the Community Center, along with what is to be done about the condition of our deteriorating street lights. The Community Pool shower was replaced in October and the new carriage lighting for our guard houses will be completely installed by the beginning of December.
