

### Tribute to Larry Mullen

TR's Maintenance Manager 2001 to 2023

Our Maintenance Manager officially retired on 12-31-2023,

after 22 years of faithful service to our community, and we will host a retirement party in his honor in the Community Center on

#### January 17 from 2pm - 5 pm

Stop by and bid Larry farewell and wish him all the best in his retirement!

A bit of history, from a personal perspective, about Larry and his hard work during his tenure on our behalf. My family built our home on Sabal Lake in 1997. At that time, everything in the community was new, the developer was still in charge, and there were few, if any, significant "maintenance" issues.

In 1999, the developer turned the association over to the members, and subsequent memberrun Boards were quickly confronted with several issues that had been left unattended—one of the major ones being the gas-powered streetlights. The pilot light would go out, bugs got into the housing, and a host of other problems prevented lights from illuminating our walkways and streets at night. The association was paying a lot of money to have an outside company maintain the glow. The thentreasurer proposed that we hire a knowledgeable, energetic, independent-thinking individual to (for the time) specifically address the numerous issues the streetlights were encountering. They found Larry—and we have benefitted from his tireless, able efforts ever since! While he may have been hired to specifically address

the streetlight problems, Larry quickly proved himself to be in-

valuable in so many other areas that affected residents' daily lives within the community. In no particular order, Larry has been handling all these issues for us for 22 years:

- servicing our pool with chemicals (obtained a license to do so)
- scooping leaves out of the pool daily
- blowing leaves off the tennis courts



Helping find a root-covered irrigation shut-off valve when a contractor hit the main line, allowing water to spew uncontrolled. The clothes were so soiled they had to be tossed.

- installing/replacing street signs
- fixing irrigation heads on common property
- helping owners find irrigation shut-off valves
- fixing irrigation heads on common property
- racing to property after-hours to address an emergency
- re-attaching gate arms that were torn off
- repairing landscape, CC, and pool cabana lights
- clearing fallen limbs, removing roadkill
- pulling dead fish and trash from our ponds,

- fixing playground and other equipment
- placing items in all bulletin boards on property
- repairing street lights (converted to solar in 2009) when there were panel/battery/bulb/ socket issues, as well as *dozens* of other problemsolving activities that go unnoticed by residents!

In short, Larry handled almost any issue that needed attention, no matter how difficult, dirty, or menial, and knew when additional help needed to be called in, such as replacement of A/C equipment. And he did it with a smile,

through 20 different managers who worked for 10 different companies!!!

Fun fact: Larry met his wife. Fleming, **Patty** here on proper-She tv. was working here as our Admin for roughly two years, from 2007 to 2008, and their friendship blossomed. Patty lived in the Savannah sec-



tion of TR, later serving as that HOA's President for several years, and has done so much for our community as a volunteer since! They have moved to Deerbrook Circle since.

Over the last 10 months, Larry has mentored his replacement, AZ, explaining the ins and outs of this large property. There are many unique challenges that arise over time, and we are fortunate that Larry has declared himself available for consultation in future should the need arise.

## **Nominating Committee**

#### **Attention All Residents...**

The Turtle Rock Nominations Committee is seeking applicants to serve on the Board of Governors. Only self-nominations are accepted because serving on the Board is a responsibility that requires a personal commitment of three years, unless filling a vacancy, and a desire to fulfill that commitment. Board members do more than merely attend the monthly meetings. Each of Turtle Rock's task forces and committees has a Board member who serves as a liaison to the Board. The Board works closely with both the management and vendors to ensure that we remain a desirable community in which to live. Once elected the Board has its Organizational meeting and elects its officers, who take on added responsibility.

Turtle Rock home owners at least 21 years of age who meet the minimum requirements are eligible to self-nominate. You must:

- not be delinquent in payment of dues or other monetary obligation to the Association;
- not be in violation of TR rules, and
- not have been convicted of a felony (if so, have your civil rights restored for five years)

We are looking for those individuals who have taken the time to familiarize themselves with our governing documents (Declaration and By-Laws) and with the Turtle Rock Owner's Manual (TROM), both of which can be found on the website <a href="https://www.myturtlerock.com">www.myturtlerock.com</a> under the heading Community Association Documents. You may also be a good candidate based on your professional background and experiences or on your participation on other Boards and committees

All owners will receive the nominations materials in the mail. Applications (also found on the last two pages of this newsletter) are due in the Turtle Rock Community Center no later than 1 pm on January 12, 2024. If there are more candidates than open positions, a Meet the Candidates Night (required attendance for applicants) will be held in person and via Zoom, with elections to follow. Once they begin their 3 year term, newly elected Board Members will also need to complete an approved course pertaining to FL statutes for HOAs which is free and available online.


