At the January 25 Board meeting the Board approved an expenditure of \$12,275 for the trimming of the oak trees along Turtle Rock Blvd and \$600 for replacement trees. The Board also approved a new law firm, Persson, Cohen, Mooney, Fernandez and Jackson, to be our attorneys to perform collection for outstanding dues and fines.

Turtle Rock's transition to our new property management company, Civix, is complete. You should have received an invitation to join AppFolio. If there is more than one email address associated with your unit, you may request the second email also receive an invitation to join AppFolio. That request can be made at the

community center with either Nanette or Nan. Civix will conduct training sessions for owners and residents on the use of AppFolio once we have had a sufficient number of people who have set up their accounts. This training will show you how to use AppFolio and access your property's records, ARC forms, documents associated with your unit and common association documents. Three Board members will have completed their threeyear term, and there are four residents who self-nominated to replace them:





Susan Burkenmier

My husband J.R. and I relocated to Sarasota in 2020. My commitment to public service began when I spent my early career in city management in Iowa and Illi-


Curt Gilroy

Chameleons

Although many people tend to focus on the chameleon's ability to change its color (both for camouflage and to attract — or warn — potential mates), this amazing lizard's tongue is an often-overlooked wonder. First, it's the <u>fastest</u> "gun" in the animal kingdom: It can go from zero to 60 mph in one-hundredth of a second!

But another surprising attribute of this incredible muscle is **that it's twice as long as a chameleon's body** on average — a handy feature when sneaking up on unsuspecting prey. Translated into human biological terms, that's the same as a person having a 10- to 12*-foot*-long tongue. So how do chameleons, which are not particularly large lizards, keep this

long tongue in such a small mouth? Well, scientists have discovered that a chameleon's tongue contains elastic tissue that allows them to effectively store this secret weapon "folded up like an accordion," in the words of National **Geographic**. When hunting prey, muscles contract in the mouth, similar to pulling back the string of a bow, and once that tension is released, simple physics takes over. The chameleon's tongue propels forward with blink-andyou'll-miss-it speed in a process scientists call "elastic recoil." Then, a supersticky, viscous fluid at the tongue's tip ensnares the whiplashed insect, and the recoil returns the freshly caught meal to the chameleon's mouth. Yum.

February's Guided Nature Trail Walks

The Natural Assets Committee (NAC) will conduct two nature trail walks in February. We hope the weather will be better than much of January's!

Turtle Trail is 1.5 miles long one way. Walks will begin at the Community Center and end at Palmer Ranch Parkway. Walkers will then have the option of returning on the trail or on Turtle Rock Boulevard. The NAC host will show walkers the new trail directional markers; native plants, birds and other wildlife; and important pond water flow structures. Please plan to bring drinking water, wear sneakers or other closed toes walking shoes, and consider a sun hat or sunscreen and insect repellent. Allow approximately 2 hours for the complete circuit.

Happy New Year to All!

The Committee met on January 10th at the Community Center. In attendance were co-chairs Joan Howe and Curt Gilroy, members Kathrin Harris, Diane Geramanis, Deirdre Cronin, Emily Miller and Jodi Cunnison along with Shane Battle from Bloomings and Nanette Thomas from Civix Property Management.

The Committee reviewed the work that needed to be done by Bloomings. Shane confirmed that the following was either done or would be completed within the week:

-dead plants replaced in the Awabuki hedge along Central Sarasota Parkway

-the dying and missing podocarpus in both medians at the north and south gate will be replaced

-the dead Shady Lady tree at the faux bridge along Turtle Rock Blvd will be replaced and irrigation will be added

-the dying tree on one of the islands on Far Oak Circle will be removed. Regarding a second island further along Far Oak Circle, the hibiscus on that island will be trimmed back

-a Shady Lady tree was planted along the pond just south of the Community Center

-the dead palm tree on the east side of Turtle Rock Blvd bordering the hammock was removed

-the dead plants on the intersection corners along Turtle Rock Blvd have been replaced

-clean up will begin along the edge of the preserve

Regarding other matters, Nanette confirmed that she was obtaining a quote to have the community pool tile repair work done. In addition, she will be reaching out to a stone mason to assess the water infiltration that is occurring in the perimeter walls of our Turtle Rock community.

After the meeting several members of the Committee drove through Turtle Rock to look at various trees, on community property, that need attending to.
