The Board of Governors has determined that each Turtle Rock Member of record who: (i) files a timely and completed application in the Management Office; (ii) is not delinquent in the payment of any fee, fine, or other monetary obligation to the Association on the day that the person could last nominate themselves or be nominated and (iii) has not been convicted of any offense which is considered a felony in this state unless such felon's civil rights have been restored for at least 5 years as of the date on which such Member seeks election to the board. The term of office for elected members is three (3) years. Please refer to Article 5.0 of the Turtle Rock Bylaws for the complete list of guidelines.

The application form for Members who wish to become candidates for the Turtle Rock Board of Governors 2021 election is on the reverse side of this sheet. Please print or type your responses and return the application ***no later than 4:00pm on Thursday, December 23, 2021*** to Turtle Rock Community Association, Inc., 8500 Turtle Rock Blvd, Sarasota FL 34238.

It is recommended that the application be completed with concise statements, as summaries will appear on the website.

FLORIDA Statute effective July 1, 2013:

F.S. 720.3033(1) *Within 90 days after being elected or appointed to the board, each director shall certify in writing to the secretary of the association that he or she has read the association's declaration of covenants, articles of incorporation, bylaws, and current written rules and policies; that he or she will work to uphold such documents and policies to the best of his or her ability; and that he or she will faithfully discharge his or her fiduciary responsibility to the association's members. Within 90 days after being elected or appointed to the board, in lieu of such written certification, the newly elected or appointed director may submit a certificate of having satisfactorily completed the educational curriculum administered by a division-approved education provider within 1 year before or 90 days after the date of election or appointment.*
