


Palmer Ranch Demographic Survey January – March, 2018 RESULTS








Q4) How many people in your household are in the following age groups?

HISTORY OF SARASOTA WILDLIFE


Join us for a presentation, led by Barry Gerber, on the history and development of Sarasota and the effect that it has had on wildlife in the area.


