Notice of Public Hearing

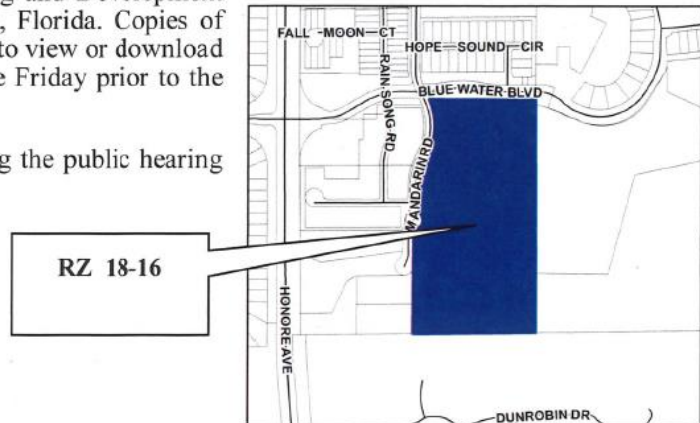
