Beverly Swain Wood is a mixed media artist who expresses her creativity through watercolor, acrylics and collage. She has lived in many diverse environments, including her native state of New Hampshire, the nation's capital, the Southeast, Arctic Regions of Alaska, Northern California and the Gulf Coast of Florida, all of which have shaped and directed her art.

Abstract in nature, Beverly's work emerges during the process, rather than from a pre-established format or concept. She identifies it as Abstract Realism and often incorporates images from her own photography, monoprints and personally designed papers. The seemingly mystical quality of her work invites and entices the viewer to further explore the images and varied textures, either real or perceived.

Beverly is a member of Artists of Palmer Ranch, Women Contemporary Artists, the Florida Suncoast Watercolor Society and the International Society of Experimental Artists. Her work has won awards in juried art shows and has been in exhibits at the Ringling College of Art and Design, Selby Gardens, City Hall, the Gulf Gate Library, and the Art Centers in Sarasota, Venice, and Manatee. It was also recently accepted in the 2019-2020 International Society of Experimental Artists online exhibit. It is presently on exhibit at the Gulf Gate Library during the month of April 2019. It will also be on exhibit at Plymouth Harbor Senior Living Center during January and February 2020 and at the Players Theater during March 2020.

Sarasota County Planning & Development Services Department wants you to know that a property owner near you has applied for **Rezone Petition 18-24** to rezone approximately 7 acres from RE-2/PUD (Residential, Estate, 1 unit/acre, Planned Unit Development) to RSF-4/PUD (Residential, Single-Family, 5.5 units/acre, PUD) zone district to develop 34 residential units.

The **Planning Commission** will hold a **Public Hearing** beginning at **5:00pm**, or as soon thereafter as possible, on **April 18, 2019, at the County Administration Center, County Commission Chamber, 1660 Ringling Blvd., Sarasota, Florida.**

You are invited to appear, be heard, and submit relevant evidence. YOU DID IT. Thanks to the Sarasota County Neighborhood Initiative Grant Program, Cycle 31, Palmer Ranch Master Property Owners Association, Inc. was able to begin our work on our very first Butterfly/Wildlife Garden. The location was chosen when upon inspection it was noted that the area was home to several Lantana plants that were prolific with butterflies. The area consists of approximately 1.41 acres of drainage easement property owned by the Master Association, only half of which was planted at this time. The property is on Honore along the VillageWalk corridor but not within the VillageWalk walls. The Garden was meant to be accessible by foot, walkers, joggers and bicyclists. For those of you who are Sarasota County Property Appraiser savvy, the Parcel I.D. # is 0119110100.

All of the above plus many more that aren't pictured helped us plant almost 350 plants from one gallon all the way up to 15 gallon. Our very generous vendors donated time, resources and materials to install irrigation, mow and kill weeds, put in handrails since the banks are rather steep and mulch over 300 bales of pine straw.

Elizabeth Wechsler who is pictured above lost her husband Bob last year. Bob was very active in the Mira Lago community and they wanted to honor him by planting a tree in his memory. Since most gated communities do not allow for such memorials, Mira Lago took up a collection and purchased two trees to plant in the garden, they purchased a Sweet Acacia and a Sweet Bay Magnolia, both of which will attract pollinators as well as hosts for butterflies. The Sweet Bay Magnolia will attract Tiger Swallowtail butterflies, one of the most beautiful butterflies you'll ever see and the Sweet Acacia with its very sweet smelling fragrant blooms will of course attract honeybees.

I cannot say enough good things about all the support that Palmer Ranch has shown for this garden. I know it will be a thing of beauty and will help pollinate our food, plants, flowers and give joy to so many people. THANK YOU from the bottom of my heart. See ya at the Garden!


