TEXAS SAGE (LEUCOPHYLLUM FRUTESCENS)



Mostly evergreen, clean and hard to kill, **Texas Sage** is indispensable to anyone designing a colorful, low-maintenance landscape. It absolutely thrives in the hot, muggy monsoon season in Tucson, AZ making it the perfect choice for Sarasota's humid, muggy weather all year round. The flowering coincides with periods of high humidity. It grows 6 feet tall. Texas Sage is called the barometer plant because as soon as the humidity begins to rise after very dry weather, this shrub bursts into bloom. This shrub is easy care and doesn't like to be fussed over. Excellent way to add color without cost to maintain!

SARASOTA COUNTY NOTICE OF PUBLIC HEARING

Notice of Public Hearings

Sarasota County Planning and Development Services Department wants you to know that a property owner near you has applied for 1) a DRI (Development of Regional Impact) NOPC (Notice of Proposed Change), and 2) Rezone Petition No. 18-17 to rezone approximately 89 acres from RMF-1/PUD (Residential, Multi-Family, 6 units/acre/ Planned Unit Development) with stipulations to RMF-1/PUD zone district with amended stipulations to increase the number of units from 360 to 371 and to designate two new access points.

The Sarasota County Commission will hold public hearings beginning at 9:00 a.m., or as soon thereafter as possible, on June 5, 2019, at the County Administration Center, Commission Chamber, 1660 Ringling Blvd., Sarasota, Florida.

You are invited to appear, be heard, and submit relevant evidence. Complete drafts of the proposed ordinances are

available during normal business hours in the Planning and Development Services Department at 1660 Ringling Blvd., Sarasota, Florida. Supporting documents will be available the Thursday prior to the public hearings at www.scgov.net, Meetings and Agendas (Meetings on Demand) to view or download.
